Welcome

Welcome to the Lifestages KiwiSaver Scheme (the 'Scheme') Annual Report for the year ended 31 March 2021. The last 12 months have been a busy period for the Scheme.

Some of the take-aways from the past 12 months were:

- > **Stick to your plan.** The market performance following COVID-19 has demonstrated the value in not only being in the right risk profile, but also in sticking to it in the face of adversity. Members in the higher risk profiles that stuck to their profile through the market slump in March 2020 benefited from the remarkable performance afterwards in the equity markets, unlike those that switched to a lower risk profile and missed out on this bounce and may now take years to claw this back.
- **Check your risk profile.** The reason that market volatility over the past 12 months may have felt uncomfortable to some of our members may have been due to the fact they were not in the correct risk profile. We highly recommend that members who have had a change in circumstances, or those

- that are saving for a first home, go to www. lifestages.co.nz/tools/mobile-app/ use our tools to make sure you are on track.
- > COVID-19 remains. While there is a lot of positive news around the pandemic, we aren't out of the woods quite yet. We might see further disruption in the coming year, and this could impact investment markets once again.

Funds Administration New Zealand Limited (the 'Manager', 'us, 'we') as manager of the Lifestages KiwiSaver Scheme (the 'Scheme') presents this Annual Report to the members of the Scheme for the year ended 31 March 2021 ('Year').

The Scheme's supervisor is Trustees Executors Limited ('Supervisor').

The Product Disclosure Statement (PDS) is dated 1 February 2021 and is open for applications. The latest fund updates for the quarter ended 30 June 2021 for each fund were made publicly available on the Disclose Register on 28 July 2021. The latest financial statements and auditor's report for the Scheme that have been lodged with the Registrar are for the year ended 31 March 2021.

Changes relating to the scheme

This section provides information on the material changes which occurred to the Scheme during the Year:

Governing document

There were no material changes during the Year.

Terms of the offer

- > On 1 April 2020 a new early withdrawal category was introduced, allowing people with a life-shortening congenital condition to withdraw their savings before the age of 65. Members who make a life-shortening congenital condition withdrawal will forgo their entitlement to the government contribution and compulsory employer contributions.
- > In addition to the above change, on 25 June 2021 (after the Year end), the Board of the Manager resolved to wind up the Lifestages Capital Stable Portfolio with effect 15 July 2021. The Manager nominated a Substitute Portfolio for reinvestment of the proceeds of the wind up of 25% High Growth Fund and 75% of the Income Fund.

Statement of Investment Policies and Objectives

The SIPO was updated as of 1 September 2020

- > Change the Strategic Asset Allocation for the Lifestages High Growth Fund; and
- > Add an SRI filter to the External Manager Policy and updating the Responsible Investment Policy.
