What is the purpose of this update?

This document tells you how the Lifestages Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide investors with a low-risk investment option that invests predominantly in income producing assets, the majority of these being cash and fixed interest investments. The Fund may also hold high dividend yielding equities and/or listed property and infrastructure investments.

What are the risks of investing?

Risk indicator for the Lifestages Income Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

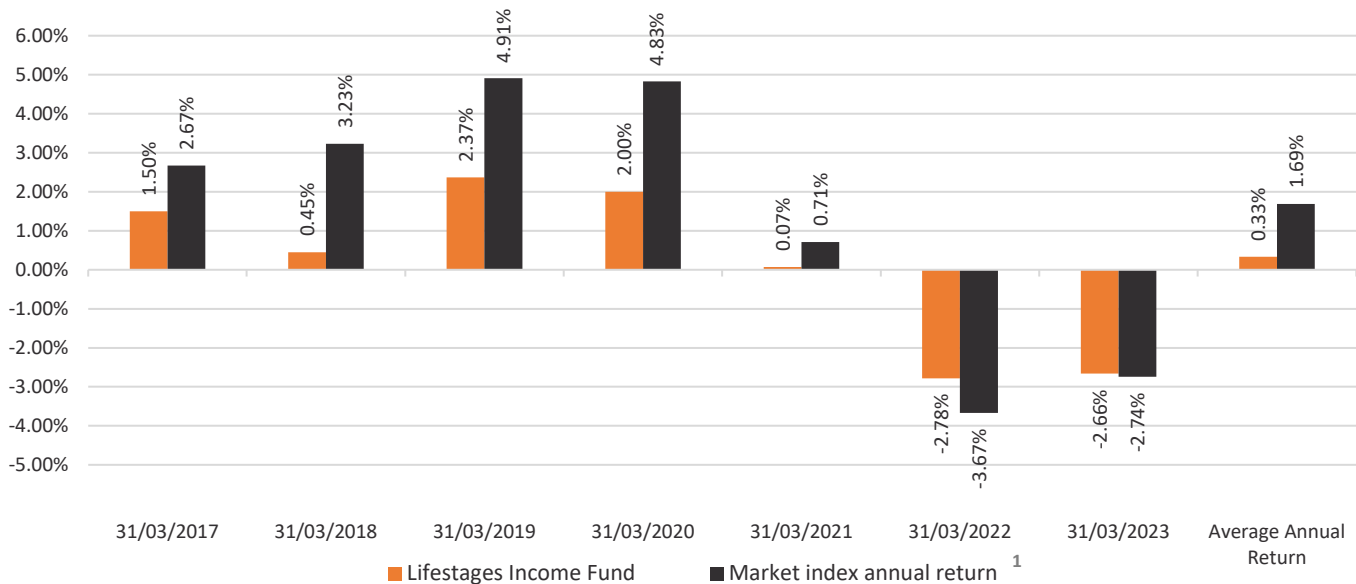
How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

* From 1 December 2022, the \$24 annual Member fee was removed. The member fee of \$16 represents the charge from 1 April 2022 - 30 November 2022. The total fund charges are expected to be 0.87% per annum in the year to 31 March 2024.

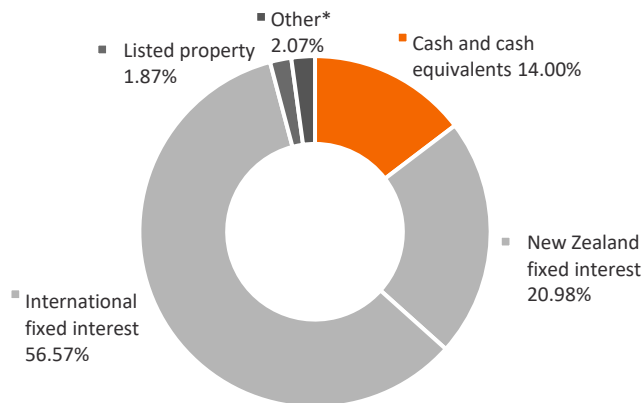
Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$141 (that is 1.41% of her initial \$10,000). Hayley also paid \$10.00 in other charges. This gives Hayley a total return after tax of \$33.00 for the year.

Currency hedging

As at 30 June 2023 the fund has an exposure to foreign currency assets of 58.64%, of which 58.64% was hedged back to NZD. This means the fund's foreign currency exposure is 0.00%. GST will be included in some expenses, where applicable. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
